



REPORT OF WEBINAR ON "WORLD ENVIRONMENT DAY"

On 5th June 2022 at 5pm webinar titled "Environment Laws and its implementation- A Reality" was organised. 74 participants participated in the webinar. The guest speaker was Advocate sathana Mahashabde. Webinar started with lord Ganesha Prayer song. Overall compering was done by Asst. Prof. Madhuri Maharao. Formal welcome was done by Incharge Principal Dr. Sushila Vijaykumar. Convener of the webinar Asst. Prof. Nisha Deodhar has given the brief information about various themes undertaken by various countries of the world to celebrate World Environment Day since 2005 till the theme "Only One Earth". In the current year, of 2022. She highlighted that 2 time so far India was the host country on the occasion of "world Environment Day" that is in 2011 with a theme "Forest- Nature at Your Service" and in 2018 with a theme "Beat Plastic Pollution." She even given the introduction of the Guest Speaker Advocate Sadhana Mahashabde.

Guest Speaker Advocate Sadhana Mahashabde has done her PHD on Environmental Legislation and also dealing the cases related to environmental matters in the Mumbai Court. and Currently appointed as Member of Maharashtra Water Resources Regulatory Authority. She has received "Rajiv Gandhi Paryavaran Bhushan Puraskar 2010" by the hands of Chief Minister of Maharashtra on 05/06/2010, Environment Day.

She started her speech by giving 50 years history of how the celebration of world environment Day started since 1972-73, after the discussion at Stockholm convention (Sweden) and how the participating 143 countries has agreed to deal with global environmental issues to local environmental problem solving. She then discussed about need to understand various environmental Laws as in India they are mostly violated. She has given the expel of Public Interest Ligation put restriction on construction of an oil industry which supposed to start near Hussein Sagar Dam near Hyderabad. She even highlighted the issue of near 340 tree cutting to the construction of elevated Bridge at Navi-Mumbai.

Guest Speaker added the role mangrove protection as it has played a great role in Assam Storm. She has done appeal to all the young participants to play the role of good citizen and launch the complaints to local police related to anybody cutting the trees, or violated any environmental laws of wet and dry garbage segregation etc. She even solved the queries asked by participating students and teachers. Asst. Prof. Madhuri Maharao, proposed vote of thanks to guest speaker, Management, I/C Principal, teaching and non-teaching staff and to all the participant. The webinar ended by playing National Anthem.
